1. INTRODUCTION

- 1.1. The Market Monitoring Guidelines ("the Guidelines") sets out the information the Authority for Info-communications Technology Industry ("the Authority") considers it will need on a routine basis to monitor compliance with, and the implementation of, the proposed regulatory changes.
- 1.2. There may be additional information that the Authority will need when investigating a specific market in detail, and the Authority has the necessary powers to require such information under the Telecommunications Order 2001.
- 1.3. The collection of information is crucial for enabling the Authority to carry out its duties. For example, high-quality information is required:
 - 1.1.1 to enable it to carry out effective market reviews;
 - 1.1.2 to ensure compliance with regulations; and
 - 1.1.3 to assess the performance of the sector by international standards.
- 1.4. The market monitoring information presently include minimal measures to ensure customers receive good quality of service (QoS). The Authority is reviewing the existing Quality of Service Code and Standards of Performance Relating to Quality of Services for Telecommunications Sector in Brunei Darussalam (2014) ("QoS Code") to address this.

2. **INFORMATION REQUIRED**

2.1. The information required is grouped into a number of categories, as set out below:

Subscriptions	Data on the number of service subscriptions in the market	 General monitoring of the market and how competition
Traffic	Data on voice and data traffic	between RSPs is developing.
RSP commercial information	RSP revenues, ARPUs and annual accounts	 Important basic information for undertaking a market review or investigating a competition law matter.
UNN pricing and compliance information	Specific information required to ensure UNN's compliance with its regulatory obligations.	 Required to determine whether UNN is complying with the remedies set out in the UNN Direction.

Category	Description	Purpose
Sector performance information	Data used to assess sector performance by international standards. The measures here use ITU definitions so that Brunei's sector performance can be compared with sector performance in other benchmark countries of similar size and GDP per head	• Essential information for comparing the overall performance of the telecommunication sector in Brunei with that in other microstates to see if the way the restructured sector is regulated is effective.

- 2.2. Data in the first three categories is already collected by the Authority. Note that the Authority may collect information for other purposes besides competition assessment and this list is not exhaustive.
- 2.3. Where a frequency is specified, it shall be taken to mean the figure as of the end of that period (i.e. monthly refers to end-of-month data). Note that for the first three categories of information, data **collected** is on a monthly basis but **provided and/or reported** to the Authority on a quarterly basis.
