# 2 APPLY FOR NEW DEALER LICENCE

a) Log In to SCP, navigate to Dealer Licenses module.

- e) For selected license type, system will check if there is an existing licence or an active application and will not allow to create the application.
- f) If new application can be applied for the selected license type, an application form will appear. The application form will have the license type selected in the *General* tab and would require used input for contact person and reason to apply.

**Note:** the company's profile of applicant must have documents such as: 'Copies of Identity Cards/ Passports', Copies of 16/17, 'Terms and conditions'

- i) When all requirements are fulfilled, click *Apply* button. Application state changes to *Applied*. The application will be available to AITI officers to be processed.

- k) Once AITI officer decides that information in the application is complete, the application is accepted and will be processed. The application status will change to 'Processing'. Notification of application processing will be receiver by the applicant.

- o) Once application is approved, depending on the payment exempt status of the application one of the following two cases will occur,

  - ii. If application is not exempted from payment, then Invoice will be generated and it should be paid to issue DL. Please refer to 'Billing (Invoicing and Payment)' guide to proceed with payment management.

## 3 RENEW DEALER LICENCE

- a) Login to SCP, navigate to Dealer Licenses module, open Dealer License screen form.
- b) Click *Renew* on the top of the form. System will open renew application.

- c) On the application form, fill in number of years for which the application is to be renewed.
- d) Click *Apply* button. Your Application is sent to AITI for approval.
- e) Once approval is performed, based on the payment exempt status following two case may occur:
  - i. If application is exempted from payment, then dealer license Start and Stop dates are updated immediately.
- ii. If your application is not exempted from payment, then license will be created in 'Pending for payment' state and an invoice will be generated. Invoice should be paid in to complete the renewal of the license.

- a) Login to SCP, navigate to Dealer Licenses module, open Dealer License screen form.
- b) Click Terminate on the top of the form. System will open termination application
